## **Processing Techniques**

BorPure RJ377MO is easy to process with standard injection moulding machines.

Following parameters should be used as guidelines:

 $\begin{array}{lll} \mbox{Melt temperature} & 210 - 260 \ \mbox{°C} \\ \mbox{Holding pressure} & 200 - 500 \mbox{ bar} \\ \mbox{Mould temperature} & 15 - 40 \ \mbox{°C} \\ \mbox{Injection speed} & \mbox{High} \\ \end{array}$ 

Minimum to avoid sink marks.

Shrinkage 1 - 2 %, depending on wall thickness and moulding parameters







#### Storage

**BorPure RJ377MO** should be stored in dry conditions at temperatures below 50°C and protected from UV-light. Improper storage can initiate degradation, which results in odour generation and colour changes and can have negative effects on the physical properties of this product.
